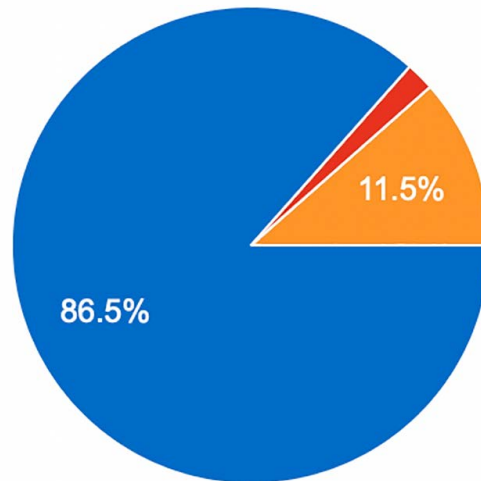

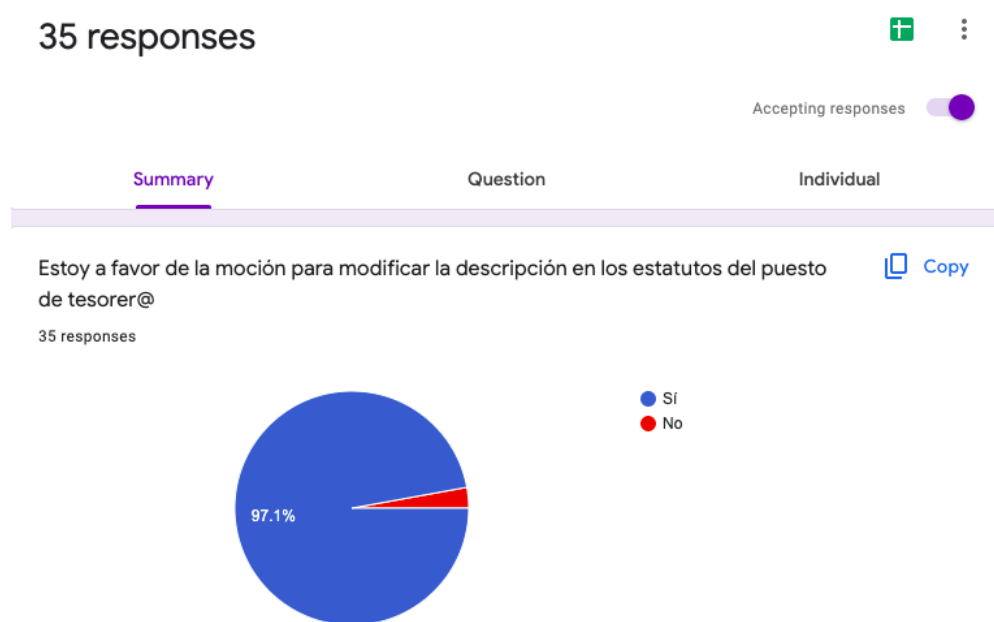

The Treasurer's job will be maintained for a minimum of 3 years and a maximum of 6 to safeguard the economic balance of the Association. The Treasurer will manage the finances of the Association. Under his/her responsibility will be the collection of membership dues and the payment of expenses incurred by the Association (*Revista de Estudios de Género y Sexualidades*, website, administrative expenses on the part of the President, Secretary, and the Treasurer). S/he will have control by receipt and photocopy of all expenses incurred by the Association. These will be reimbursed to the relevant people after consultation with the President. He/she will keep the accounts of the Association and submit a report on the state of the Association's accounts to the Executive Committee (at least three times a year) as well as update the membership list (which movement will inform the President monthly, not every 6 months). S/he will be in charge of sending necessary monthly reminders, so that members pay their dues (international members should receive the necessary reminder by ordinary mail in the absence of email). His/her annual report will be included in the minutes of the General Assembly.

Cambios propuestos

The Treasurer's position will be held for a minimum of 3 years and a maximum of 6 to safeguard the financial stability of the Association. The Treasurer will manage and keep records of the finances of the Association. The Treasurer will process the membership dues and payments incurred by the Association (including but not limited to REGS Journal, Website, Victoria Urbano Awards, grants for graduate students, e-chapters and other administrative expenses). Payments and reimbursements will be made after consultation with the President. The Treasurer will provide updates related to the Association's accounts, and submit reports to the Executive Committee (at least three times a year). The Treasurer, in consultation with the Secretary, will provide the President with a monthly update on the most up-to-date membership list. The Treasurer's report will be included in the minutes of the General Assembly.
